Lying on the Northeast side of Pee Dee River in the district of Marlborough and also all of the land included between the road which leads from my Mill to Cheraw Hill, the line of the tract on which the said John now lives and codar creek excepting so much out of the same as is requisite for the Will seat and also excepting the grist Will standing there on out of the same. and also I give- and also I give and devise unto my sen Charles Dewitt his heirs all of my plantation lying on both sides of Peedee River, known by the name of James plantation and also the out or back lands attacked to the same excepting a tract of Eighteen acres. And also I give and devise unto my Grandsen William T. Dewitt and his heirs all of my plantation knows by the name of Butter plantation lying on the Mgrth - East side of Peedee River subject to this condition that if the said William should live to become Twenty one years of age or to Marry and have Issue but if the said William should not live to become Twenty One years of age or to Marry and have Issue then I give and devise the Said Plantation to ay som John and his heirs. and also I give devise and bequeath unto my Daughter DerothyDewitt and Harriot Dewitt and Mheir heirs to be equally divided between them my dwellinghouse and Mills and also the land attached to them my house hold furniture and Stock of Horses Cattle and Hogs on this side of the river on which I live. and also I give and bequeath unto my Baughter Dorothy the following Megroes (Vis) Harry and his family Henny Jack & Selemoon and also I give and bequeath unto my Daughter Harriett the following Negro Slaves (Vis) Charles and his family Cassar Cate Scham & Jeff. and also I give and bequeath unto my Daughters Mary Edwards Eleanor Chapman Betsey Wilds and Peggy Handford five thousand Dellars to each to be paid to them by my Executors immediately after my decase in money

or personal Estate at a fair valuation. and also I give and devise unto my Daughter Peggy Hanford and her heirs a tract of land containing Eighteen acres bounded on all sides by land belonging to Enoch Hanford and here and before excepted out of the land attached to the James plantation. And also I give and devise unto Enoch Hanford and his heirs a Strip of land lying on the tract on which my house Stands on the dide next to Evander McIvers two rods in width Commencing on the road which leads from pouncys Ferry to the long Bluff running next to and parallel with the said Evander McIvers line to his corner in an old field and then all the land included between the hime of the said slip of land deviding it from my continued direct to an old pine near the read which leads from my Mill to the long Bluff and then continued direct to the said road and the said Snock Hanfords & Ewander McIvers lines. and I direct and authorized orise my Executors hereafter to be named to make sale of the following tracts of land (Viz) a tract lying on Harris creek a tract on the south side of cedar creek called W. Douglas tract a tract lying on Rudy Branches a tract lying on the Swamp called the Lucas tract. and all the lands lying on the south side of coder creek down to John McIntoshs upper corner and a line continued from fence to the said creek, and also I give bequeath andidevise all of the residue of my estate to be equally divided among all my children. and lastly I do hereby nominate and appoint my sonsJohn nad Charles and allen Chapman Executors of this my last will and testament hereby revoking all former Wills by me made.
